CHS is responsible for respiratory protection training and fit testing; monitoring, screening and vaccinating against communicable diseases; managing exposures; and promoting well-being practices and activities.

Confidentiality

We respect the confidentiality of individuals and handle all information in accordance with legal requirements and our own policies. Caregiver health records are maintained in a separate occupational health database or in separate files from other employment or HR-related records.

Vaccination Records

Medical Surveillance

Annual surveillance will be performed according to OSHA or local health authority requirements and may include tuberculosis testing, hearing tests, respirator training, or testing related to potential environmental exposures.

Blood and Body Fluid Exposure

Caregivers who experience a blood or body fluid exposure may receive baseline and follow up blood testing, necessary immunizations and education through Caregiver Health Services. After sustaining a blood and body fluid exposure, caregivers should complete first aid then notify their core leader and CHS immediately.

Vaccinations

We also offer vaccinations for measles, mumps and rubella (MMR), Hepatitis B, varicella (chickenpox) and tetanus, diphtheria and pertussis (Tdap), and the annual influenza vaccine following Centers for Disease Control and Prevention (CDC) and local health authority guidelines.

Medical Surveillance

Annual Flu Vaccinations

Seasonal influenza vaccinations are provided to caregivers each fall. Caregivers are asked to get a flu shot or complete a declination form. Caregivers who decline the vaccine may be required to wear a mask during influenza season in some locations. Please see your local policy for details.

Tuberculosis Screening

All new caregivers will be screened and most will be tested for tuberculosis (TB) as part of the onboarding process. Annual TB surveillance is conducted in ministries and regions where required.

Respiratory Protection Program

All caregivers whose work requires the use of an N95 mask or Powered Air Purifying Respirator (PAPR)/
Controlled Air Purifying Respirator (CAPR) must first complete the Occupational Safety and Health Administration (OSHA) Respirator Questionnaire, be medically cleared for training and receive respiratory protection training. Annual fit testing and training is required.

COVID-19

All workforce members working on site are encouraged to receive all updated COVID-19 vaccines or complete a declination if unable or unwilling to be vaccinated.

Exposure Management

If you are exposed to a communicable disease, CHS will:

- Monitor and follow-up once your exposure is confirmed.
- Provide guidance on work limitations for exposures that occured in or out of work.

If you are diagnosed with a communicable disease, please contact CHS Call Center (949-534-4450) for reporting and clearance to return to work.

What to do when you are sick

Caregivers with the following symptoms should notify their core leader and CHS and should not come to work:

- A fever of 100.4F or higher, by itself or with any of the following symptoms: cough, runny nose or sneezing, sore throat, or swollen glands in the neck
- Any draining skin lesions which cannot be contained by an occlusive dressing
- Redness and/or discharge from either eye
- Acute vomiting and/or diarrhea (3 or more loose stools in 24 hours) such as gastroenteritis lasting longer than 24 hours, or which is accompanied by other symptoms (e.g. fever, abdominal cramps) must be evaluated by their healthcare provider before returning to work.
- New, undiagnosed rash with or without fever.
 Rashes must be evaluated by your health care provider and cleared through Caregiver Health Services before returning to work.
